Proposal for setting up of 4(four) Regional  
offices at Lunglei, Aizawl, Kolasib & Champhai.

Sir,

With reference to the subject indicated above, I have the honour to state that this department being a developing department is at present actively going forward in implementing important subjects allocated to Trade & Commerce department and has compelled the department to have more man power for proper implementation of its subject. The work-load of the department is at present increasing due to the following reasons -

1. Transfer of markets and its management from Local Administration Department and Land Revenue & Settlement department to Trade & Commerce department is in the final stage .
2. Transfer of Legal Metrology department to Trade & Commerce is actively taken up by the Govt.
3. Schemes for construction of market yards/ sheds and development of markets in various selected towns and villages of Mizoram with the help of loan to the tune of Rs.2.57 crores from NABARD has been approved in principle by government of Mizoram as well as NABARD authorities for the year 1998-99.
4. A sum of Rs. 2.00 crores has been approved by the Ministry of Commerce for Zokhawthar Integrated Complex during the year 1998-99. Trade & Commerce is the nodal department for the Border Trade with Myanmar and is therefore responsible for these construction and implementation of the Border - Trade.
5. The Mizoram Trading Regulation for promotion trade and its regulation within the State is in its final stage.
6. The State Master Plan for development of Master Plan for development of Markets in Mizoram prepared by Directorate of Marketing & Inspection, Ministry of Rural Areas & Employment Govt. of India, Faridabad is approved by the Govt. of Mizoram and shall be implemented soon.

7. A sum of Rs. 445.00 lakhs for Trade & Commerce department under Plan and Rs. 30.30 lakhs (Non-Plan) Trade & Commerce and Rs. 82.00 lakhs (Non-Plan, Agril. Marketing) during 1998-99 has been provided in the Budget.

8. Trade & Commerce is made the nodal department for Marketing of Ginger Powder & Rhizome and responsible for the over-all supervision of the 500 Nos. of Dryer Machines to be given on Loan to farmers.

9. Trade & Commerce is also responsible for the Marketing of Tung.

In view of above, creation of 4 (four) Regional offices to be headed by Marketing officer with a number of supporting staff is proposed. The Annual Plan 1998-99 also provided creation of 4 (four) Districts/Regional offices at Kolasib, Champhai, Lunglei and Aizawl.

The tasks involved under the purview of Trade & Commerce like promotion & regulation of trading in Mizoram and improvement of Agril. Marketing and its infrastructure can not be confined in the state capital only. Besides these, it will be difficult and ineffective to administer ~~under~~ development of markets in Mizoram under the state master Plan, from the Head quarters i.e. Directorate office therefore, setting up of Regional offices are urgently required for smooth, efficient and effective administration of the department.



Sir,

In continuation of this Departments letter under reference and in pursuance of the statement made by Hon'ble Minister i/c Finance, Planning etc. in the last Assembly Session, I have the honour to state that this Departments proposal for setting up of 4(four) Regional Offices can not be implemented till date due to absence of pessitive response from the Government.

Meantime, this Department deeply feels the necessity of setting up of at least 2(two) Regional Offices during the current financial year 1998-'99 to operate checkgate for controlling unauthorised and illegal movements of various traders especially at Champhai in Aizawl East District and at Tlabung in Lunglei District and for proper implementation of the Mizoram State Agriculture Marketing (Regulation) Act and the Rules thereunder.

The proposed setting up of 2(two) Regional Offices will not involve additional financial expenditure as it is intended to manage the offices by existing staff of this department.

In view of the above circumstances the Government is requested to convey approval for setting up two Regional Offices i.e. one in Aizawl 'E' District and another one in Lunglei District w.e.f. September, 1998.


