2. Quotation chhanna envelope chu sealed tur a ni. Quotation chhangtu chuan a chhanna rate figure leh words in a tarlang tur a ni. Over-writing pawm a ni lovang.
3. Quotation chhangtu chuan full address, House No. leh Phone No. a ziak lang tur a ni. Quotation chhangtu chuan heng Voters I.D (attested copy), House Tax Payee Certificate, Residential Certificate D.C. Office atanga lak ngei thil tel tur a ni.

5. Lunglei, Champhai, Serchhip Market te a hrang theuh a chhan tur a ni.
6. Quotation chhang hniam ber a in hnukdawk a nih chuan a call deposit a chan hlen ang. A chhang hniam ber dawttu chu Director in a chhan leh vang pe kher lovin a pawm lo thei ang. In hnukdawk an awm a nih chuan tender chhanni in an in hnukdawk tur a ni. A hnuah pawm theih a ni lovang.
7. Quotation chhanna reng reng Director in a chhan leh vang pe kher lovin a pawm in a pawm lo thei ang a, Quotation chhang hniam ber thlan ngei ngei tur a ni kher lovang. Chhanna rate in ang 2/3 a lo awmin sawrkar thu thlukna chu thu tawp a ni ang.
8. Quotation chhang hlawhtling tu chuan dahkham, a chhanna zat atanga 6% (Performance Security Deposit) atan Fixed Deposit hmangin a dah tur a ni. 12. Aizawl khaw chhunga Market-te New Market, Bawngkawn, Vaivakawn, Mission Veng, Ramhlun Market a bawlhhlawh paihtu te chuan Trade & Commerce Department-in a paihna hmun tur a buatsaih mek Lengte Dumping Ground peih fel a nih hma chuan Tuirial Dumping Ground ah paih tur a ni.
13. Bawlhhlawh paihna Bill hi Department in Pawisa a neih dan a zirin thlahnih (2) dan zelah 3 installment in DMO/MO i/c te rem tihna (certified) in pek thin a ni ang. Final Bill chu an term tawp hnuah leh Government Sanction hmuh a nih hunah chauh pek a ni ang.
